Article 1 Name

This organizations name shall be <u>Watch Tower Ohio</u> and shall be commonly referred to as Watch Tower.

Article 2 Mission and Purpose Section 1 Purpose

Ensuring the preservation of a republic form of government and for the protection of the rights and freedoms of all legal citizens of the state of Ohio guaranteed by the constitution and Bill of Rights of the United States of America without infringement or compromise.

Section 2 Objectives

- **1.** Help Citizens of the state of Ohio to join or found a Chapter in their local area.
- **2.** Acquire facilities for education and use by the Organization.
- **3.** Acquire assets to be prepared for any emergency events.
- **4.** Create a statewide communications network for all members.
- **5.** Get in to politics on the state and federal level to counter and fight the assault on our freedoms and republic form of government.

Article 3 Membership Section 1 Membership Requirements

- **A.** Must be 21 years or older to join.
- **B.** Must be a natural born citizen of the United States of America.
- **C.** Must be a current citizen of the state of Ohio for no less than 5 years.
- **D.** All members must meet agreed upon financial obligations.

Article 4 Finance and Budget Section 1 Dues

All members pay an annual due of \$24.00 (\$2 for each month), due on the 10th day of December of every year. Dues are non-refundable.

Section 2 Non-Budgeted Transactions

The Finance Committee must approve all un-budgeted organization transactions.

Section 3 Yearly Budget Division

Annually, on the 10th day of January the organization will contribute the following percentages of the held finances to the following endeavors:

- 2% to Treasury.
- 2% to Records.
- 3% to Legal Funds.
- 3% to Communications.
- 4% to Training Programs.
- 5% to Security.
- 5% to Asset Expansion.
- 5% to Facility Acquisition and Expansion.
- 7% to Special Projects.
- 7% to Logistics.
- 7% to Public Relations.
- 10% to Political Issues.

Article 5 Officers Section 1 Terms & Limits

- **A.** All officer positions are voluntary.
- **B.** In the case of two or more members, volunteering there will be a vote to decide.
- **C.** All positions are for Terms of three years.
- **D.** Any member may Serve with no limits to the number of terms.
- **E.** Elections take place every 3 years on the 30th day of January.

Section 2 Ranks and Responsibilities

A. Head of Logistics and Operations

Handles organization projects and coordinates organization efforts. Also responsible for transporting people and materials where needed by the organization.

B. Head of Security and Training

Training of members and unit lead during tactical operations.

C. Head of Public Relations

Handles all public relations issues such as social media and setting up events and handling recruitment.

D. Head of Communication

All internal communication such as emails, newsletter, etc.

E. Head of Treasury and Records

Keeper of all organization records and organizes records of all transactions and handles all accounts for the organization.

F. Chapter Rep

Each county chapter will vote on a representative for the chapter to attend votes and meetings.

Article 6 Committees Section 1 Prime Committee

- **A.** Officers and reps only meeting. Going over organization business and projects.
- **B.** Prime Committee Meets the first Saturday of every month.

Section 2 General Committee

- **A.** General meeting for all members to talk about ideas, vote, and ask questions.
- **B.** General Committee Meets every three months on the first Saturday of the month.

Section 3 Recruitment Committee

- A. Head of Security and Training, Head of Public Relations, Local Chapter Rep.
- **B.** Meets the first Saturday of every month.

Article 7 Conflicts Of Interest Section 1 Member Expulsion

Members will be ejected from the organization in case of the following:

- A. Cannot meet financial obligations.
- **B.** Has beliefs or interests that conflict with the Constitution or Bill of Rights.
- C. Has any beliefs or interests conflicting with the organization.
- **D.** Causing direct or indirect harm to the organization.
